Facts

- 90% of Americans and 74% of NRA members support background checks for all gun purchases
- Currently only 60% of gun sales are covered by current background check gun laws, leaving 40% with no background checks (gun shows, internet sales, non-licensed dealers)
- 4.5 million children live in homes with at least one loaded and unlocked gun
- Every day 19 children under the age of 17 are shot and 7 die from these injuries
- In states with mandatory background checks for all gun purchases, suicides and gun related deaths have declined by 49%
- H.R.8 was introduced in the House on Jan, 8, 2019 marking the anniversary of the Gabby Giffords shooting in 2017

1. I support H.R.8 the Bipartisan Background Checks Act of 2019.
2. I support H.R.8 that expands universal background checks on ALL gun sales.
3. I support H.R.8 that will close Brady Bill loop holes to cover ALL gun sales including internet, private sales, and non-federally licensed dealers.
